QUOTATION AND PURCHASE ORDERS

A written quotation for the requested service and price will only be provided at the customer's request. Our price list, valid for the current year, shows our prices and services.

Additional services not included in the quotation will be charged according to time spent and the current price list. If the customer or his representative or employee agrees to the provision of additional services (verbally or in writing), this will be considered an official purchase order.

ORDER EXECUTION

EMC-Testcenter guarantees the professional execution of the orders in terms of technical and normative specifications. The test/calibration instruction is always an integral part of the order. The test results are documented and, on request, recorded in a test report/calibration certificate. EMC-Testcenter endeavours to carry out the orders on the agreed test dates.

The customer and/or persons authorised by the customer may be present during the tests/calibration. For EUTs that could potentially cause harm to personnel or the environment, adequate protective measures must be provided by the customer. (e.g. appropriate laser safety goggles for equipment containing Class III or higher lasers).

Projects lasting longer than 6 months may cause additional efforts due to updated requirements of certain certification schemes, this could lead to extra costs for customers.

RESERVATIONS, ANNULATIONS AND INVOICING

EMC-Testcenter reserves the right to automatically cancel provisionally reserved test dates if the customer does not confirm them within 2 weeks prior to the reserved date.

Cancellation of a 1-day test booking up to 2 weeks before the test date is free of charge. If a test date is cancelled or postponed later, a cancellation fee of CHF 300 to CHF 1,000 will be charged.

In case of cancellation of 2 or more test days, the full cost will be charged, unless the test days are booked by other customers. The minimum duration of a test at the EMC-Testcenter is half a day or 4 hours. The EUTs shall be unambiguously identified so that it

is not accidentally exchanged with other equipment.

EUT DELIVERY & SHIPPING

The customer is responsible for the delivery and collection of the EUT.

Within the retention period, the customer can order copies of the reports/certificates, for which a handling fee will be charged.

DAMAGE EVENT, LIABILITY

The tests/calibrations performed at the EMC-Testcenter are normally non-destructive. During immunity tests and certain electrical safety tests, destruction may occur on equipment that is not adequately protected.

EMC-Testcenter is not liable for failures or destruction that occur during immunity or electrical safety tests according to the required standard. However, EMC-Testcenter shall exercise due diligence. EMC-Testcenter is liable for self-inflicted material damage to the tested equipment caused by improper handling, testing or operation up to CHF 5'000'000.- per case of damage (insured amount of damage including consequential damage).

If the value of the equipment/system to be tested exceeds CHF 100'000.00, this must be declared in advance, otherwise any liability is excluded.

COMPLAINTS
